

The Equipment Protection Plan provides coverage for loss, theft, accidental damage* (catastrophic damage only** for Premier customers) and mechanical breakdown (after the manufacturer’s warranty expires). All iPhone models enrolled in the Equipment Protection Complete or Premier Plan have a \$175 deductible per approved claim. Below is a list of Apple devices covered by the Equipment Protection Plan.

* Accidental Damage claims under the Complete Plan may fall under one of two categories (Accidental Damage: Screen-Only Repair or All Other Accidental Damage). Approved claims for Accidental Damage: Screen-Only Repair have a service fee/deductible of \$29 when service is provided through an Assurant authorized service provider when and where repair service is available. Otherwise a replacement is available for the All Other Accidental Damage service fee of \$49 or \$99.

** Catastrophic damage is an unexpected and unintentional external event that results in irreparable physical damage (such as being broken into more than one piece or melted) which permanently prevents the device from operating as intended by the manufacturer. The damage shall not be foreseeable and shall be beyond your control or the control of anyone you entrusted with your device.

With the Premier Plan, you’re eligible for one claim, at which point the plan will terminate. After you’re approved claim, you’ll be automatically upgraded to the Complete Plan to ensure continuous protection. With the Complete Plan, you’re eligible for two claims within a 12-month period. Coverage will terminate upon your second approved claim within that period. A per claim limit of \$1,500 applies for either Plan. Equipment Protection covers your Bluegrass Cellular device, standard battery, standard charger, and SIM (if applicable to your device). Accessories provided as part of your original device purchase are covered only in the event of the simultaneous loss or theft of both the device and accessories. Malfunctioning/damaged devices must be returned within 10 days of receiving your replacement device. If the device is not returned, you will be charged an unrecovered equipment fee of up to \$900.
